Notice of Apprenticeship Opportunity for Journeyman Electrical Wireman

The Motion Picture Industry Joint Apprenticeship Committee (JAC) will be accepting applications for apprenticeships in the occupation of Journeyman Electrical Wireman.

You must apply in person at Contract Services, 2800 Winona Avenue, Burbank, CA 91504, ONLY on the dates listed below:

Wednesday, June 6, 2018 through Friday, June 8, 2018 from 9:00 a.m. – 3:00 p.m. and Saturday, June 9, 2018 from 8:00 a.m. – 2:00 p.m.

Applicants must meet these minimum requirements:

- 1. Must be a minimum of 17 years of age in order to apply. However, applicants selected from the pool of those interviewed must be at least 18 years of age before being indentured.
- 2. Must be at least a high school graduate, have a GED, **or** have a two-year Associates Degree or higher. Must submit a DD-214 to verify military training and/or experience if applicant is a veteran and wishes to receive consideration for such training/experience.
- 3. In order to qualify for an interview, applicants must pass the electrical trade's aptitude test developed and validated by the American Institute for Research. Applicants will be notified via mail of testing dates and times.
- 4. Before being indentured, applicants selected from the pool of those interviewed may be required to provide results of a physical examination, color vision test and drug test.
- 5. Individuals who can verify, by providing the proper documentation, a minimum of eight thousand (8,000) hours worked specifically in the electrical construction trade, do not need to meet requirements 2., above and a. below.
- 6. Applicants who have worked a minimum of forty-five hundred (4,500) hours as a Residential Wireman under a IBEW/NECA local collectively bargained agreement do not need to meet requirements 2., above and a. below. Instead, applicant must provide the proper documentation verifying work as a Residential Wireman.
- 7. Applicants who have completed at least three years of related instruction and forty-five hundred (4,500) hours of "on-the-job-training" as indentured in a properly registered electrical construction apprenticeship program not sponsored by the IBEW/NECA do not need to meet requirements 2., above and a. below. Instead, applicant must provide proper documentation in order to verify work in such apprenticeship program.

Applicants must provide the following at the time of submitting an application:

- a. Documentation to prove the successful completion of either one full year of high school algebra with a grade of "C" or better; or one post-high school algebra course with a grade of "C" or better; or verification of successful completion of an online course at the National Joint Apprenticeship and Training Committee (NJATC) website at www.njatc.utk.edu.
- b. An official, sealed, transcript for high school and post-high school education and training. Unofficial transcripts and/or transcripts that are not sealed may be declined at the discretion of the JAC.
- c. All GED records must be submitted if applicable. Records not sealed may be declined at the discretion of the JAC.
- d. A valid driver license **or** a state, or federally issued identification card.

We are not responsible for delays in obtaining official transcripts. Applicants who do not have all of the required documents, as listed above, at the time of application will not be considered. No exceptions.
